2022 CONTRACTOR'S SAFETY PERFORMANCE AWARDS



AWARD CATEGORIES

-General -Specialty -Technical -Other

Contractors are placed into three award categories determined by annual man hours:

- Category I – 5,000 to 75,000
- Category II – 75,001 to 500,000
- Category III – Greater than 500,000

ELIGIBILITY REQUIREMENTS

Contractors must have a current PQF and PSM Audit on file with the Safety Council of Southwest Louisiana. Visit safetyswla.org or industry pqf.com website to update or begin the process.

Nominees must have worked a minimum of 5,000 man-hours in a LAIA facility. Hours may be aggregated for work at multiple locations. For a full listing of LAIA facilities please see the LAIA member directory.

PROCESS

- Nominations can be submitted by an LAIA facility owner, the Safety Council, SLCUC, LAIA or a contractor can nominate themselves.
- Contractors will be placed in a work category of General, Specialty, Technical or Other based on the information provided in iPQF.
- Written programs, best practices, and program enhancements must be submitted in a presentation booklet or flash drive that is not included in the iPQF.
- The program audit team will review submitted entries and contractors may be contacted for clarifications.

PROGRAM AUDIT INFORMATION

Entry material must contain the following information:

- A letter supporting your nomination signed by a member of an LAIA facility
- Management systems used to support the safety performance of the organization
- Methods for measuring performance beyond OSHA statistics
- Written safety program and worker compliance training
- Drug & alcohol program
 - Drugs and medications tested, the cutoff level, and frequency of testing
- OSHA 300 log (3 years)
- EMR data (3 years)
 - OSHA & EMR data must be drawn from work performed in area facilities, not corporate data. If local data is not available, a detailed memo which defines how the data was derived must be included. The data is based on the most recent calendar year and reviews a 36-month historical period.
- Accident investigation protocol
- Any other pertinent supporting documentation
